FROM THE EXECUTIVE DIRECTOR

Abundance in an Age of Limits



Limits constrain our lives, and insufficiency lurks on the horizon. Our vision of the rich possibilities of life is obscured by the fog of scarcity. Dwindling retirement funds, disappearing jobs, and deepening debt weigh our spirits down. These are hard times—the hardest we have known in this country since the Great Depression.

Would it surprise you, then, that I invite you to consider the abundance of your life?

Look to the East in the evening and let your eyes drink in the orange glow of sunset on the Sandias. Awaken early in the morning to the melody of the bright chirping of the birds outside your window. Most of all, a gracious God who promises for some incomprehensible reason to tolerate my inadequacies and love me anyway, gives me joy and hope.

This is an age of severe limits, but only in material things that we have come to value too highly. Meanwhile, we are surrounded by abundance, and all we must do is notice it, embrace it, and give thanks.

Service and Program News



CO-PARENTING CLASSES AND WISEPARENT COUNSELING, MEDIATION AND SETTLEMENT DURING DIVORCE

The Samaritan Center for Changing Families continues to expand services to help families who are in conflict due to separation, divorce or time-sharing disputes involving their children. Co-parenting couples come to SCCF on their own, referred by attorneys or via court order.

Wiseparent Program. Counseling to assist divorced or separated couples with communication and decision-making that are in the best interests of their children.

New Cooperative Parenting and Divorce. An eight-week class for couples to learn critical information and skill-building to improve communication and conflict resolution during separation or divorce, again with a focus on the best interests of their children.

New Kids in Transition (KIT). Special group setting to fill the need for children ages 7 - 10 adjusting to changes in their families due to parental divorce or separation.

STATEWIDE EDUCATION AND SUPPORT, PROVIDED IN ENGLISH AND SPANISH, TO STRENGTHEN THE RELATIONSHIPS OF ENGAGED, MARRIED AND COMMITTED COUPLES

Super Seminars. 180 couples attended the annual Healthy Marriages Super Seminar on April 18 - held in Albuquerque and in Santa Fe. Each year we sponsor a national speaker to provide practical training to help couples resolve conflict and improve their relationships while also learning about more in-depth services available through Healthy Marriages. A Super Seminar in Spanish is planned for June.

Summer Classes and Training. A busy summer is planned with Relationship Enrichment services offered to couples via classes, small groups or couple-to-couple mentoring. We are also recruiting and training new Wise Couples and adding a "Booster Session" in June for all Healthy Marriages couple alumni.

Sustaining Partners. In our third year of Healthy Marriages we continue to not only directly offer services but also to build long-term sustainability for the program via strategic partnerships. Our Sustaining Partners are churches and community organizations committed to Healthy Marriages' vision to support and nurture healthy relationships throughout New Mexico. These partners provide meeting space and other resources, including Wise Couples, that we train to provide local Healthy Marriage education within their community.

CULTURALLY-SENSITIVE COUNSELING AND RESOURCES, PROVIDED IN SPANISH AND ENGLISH, TO STRENGTHEN FAMILIES OF ALBUQUERQUE'S INTERNATIONAL DISTRICT (SOUTHEAST HEIGHTS)

Fundraising. The St. Joseph Center for Children & Families Community Board has committed to raising \$10,000 during 2009 to support the program's work. Over \$1,300 was raised at the May 2 rummage sale, the first of several fund raising endeavors this year.

Infant Mental Health. SJCCF has begun accepting referrals to work with families with young children. Program therapists are completing a Value Options-funded ten-month specialized training program in infant mental health.



EMPLOYEE ASSISTANCE PROGRAMS, COUNSELING AND CAREER SERVICES FOR BUSINESSES, NON-PROFIT ORGANIZATIONS AND RELIGIOUS COMMUNITIES

Workplace Services saw its 1000th new client in January and continues to respond to the business community's need for short term counseling through Employee Assistance Program services. New EAP contracts include Reliance Corporation, NetGain Corporation, Heritage Home Health Care and ACCION New Mexico • Arizona • Colorado, in addition to regular referrals from EAPs from across the country.

Program director Tim Strongin, PhD, was selected by the American Red Cross to represent the Mid-Rio Grande Chapter as a lead instructor for the Red Cross' Psychological First Aid for Military Families Course, developed specifically to help military family members respond to the stress and strain surrounding the deployment of a loved one.



SPIRITUAL RENEWAL AND RESOURCES TO STRENGTHEN CHURCH LEADERSHIP AND CULTIVATE VITAL CONGREGATIONS

New Congregational Renewal Program. Clergy and lay leaders from six congregations meet for nine months with Called Back to the Well to develop practices to center every facet of church life (worship, education, stewardship, meetings) on God's purpose and transforming power. There are just a few spaces left for churches to sign up for the nine-month series beginning in the fall of 2009.

Fundraising. Welcome to Marian Bolton, CFRE, who is working with CBTW as a fundraising consultant. She brings experience and vision as well as a passion for servant leadership.

New Congregational Partnerships. We've begun contracting with churches to meet their varying needs for counseling sessions, training, retreats, customized workshops, guest preaching, and other resources.

ANNUAL REPORT 2008

The Samaritan Counseling Center concluded 2008 with another successful year of growth in service to children, adults, couples, families and faith groups in central New Mexico.

HIGHLIGHTS OF 2008:

- ✔ Completed 22 years of service, providing counseling, education, healing, reconciliation, and personal and spiritual growth to more than 29,000 people
- ✔ Provided \$4M in charitable services over our 22 year history
- ✔ Increased services more than 42% serving 5,000 people in 2008 and raised \$1.18 million for operations, endowment and grants
- ✔ Prepared nine mental health interns for work in the professions of social work, psychology, marriage and family therapy, and counseling through Samaritan's Training and Internship Program
- ✔ Raised \$1.34 million (multi-year total) for the endowment via the Spirit of Samaritan Campaign for Hope
- ✔ Workplace Services generated \$58,813 in revenue via Employee Assistance Program contracts. Using the Pathfinders-founded social entrepreneurial concept, Workplace Services helps fund Samaritan's mission of providing mental health services to all, regardless of ability to pay.
- ✔ Received \$2,500 grant from PNM for energy savings - Samaritan is grateful to be a recipient of a grant awarded to selected non-profits by PNM to support implementation of energy savings measures to decrease electricity use. We used the funds to replace two older office refrigerators and a dishwasher with Energy Star® appliances.

From the Clinical Director

The Samaritan Counseling Center continues to provide mental health services to children, adolescents, adults, couples and families in need; and with the growing number of uninsured and unemployed, that need is rising. For many people, additional stress from economic pressures is taking a toll. As Samaritan has always done, we offer services to people who otherwise would not be able to receive them. Some of our programs provide educational services at little or no cost, in both English and Spanish.

Samaritan is unique in the community because we have several different and varied programs that support traditional therapy. The Samaritan Center for Changing Families not only has therapists seeing clients for divorce issues, but also teaches classes for parents who want to improve their communication skills and lessen conflict, which are very helpful to their children. Also, a group is being formed for children of divorce called "Kids in Transition" to assist children ages 7 to 10 to adjust to the changes in their families. St. Joseph Center for Children and Families, located in the International District, works with Spanish-speaking families at low- or no-cost,

and receives guidance from an active Advisory Committee composed of people from their community. Workplace Services is yet another Samaritan program where people can receive EAP counseling, consultation for businesses and companies, and coaching for managers and executives. The Guhl Center for Children and Adolescents has therapists who specialize in working with children and their families, and has received very high marks in feedback surveys for the sensitive, caring counseling given.

The Training Program at Samaritan has grown as well. We now have nine interns with a broad range of backgrounds: social work, marriage and family therapy, counseling, and psychology, including two post-doctoral fellows in psychology. These therapists bring enthusiasm and familiarity with the latest advances in the mental health field, which energize and stimulate all the therapists.

The Samaritan Counseling Center message to people with emotional pain is that we are here to help them *find wholeness and healing* through our need-based programs and specialized services.

Samaritan Partners with United Way

The Samaritan Counseling Center is fortunate to partner with the United Way of Central New Mexico in several important ways. We were pleased, first of all, to receive word this month that Samaritan has been granted a \$60,000 grant from the community fund for the coming year to help support our "Coordinated Care for Children" program. United Way funds will be used to underwrite fees for low income and uninsured children and families who will receive counseling through our St. Joseph Center for Children & Families, our Center for Changing Families, and our Guhl Center for Children & Adolescents.

Many United Way donors also designate their gifts to support Samaritan's important work in the community, opting to direct their donations to specific Samaritan programs.

We are also partnering with United Way and the Albuquerque Community Foundation in a planned giving program. Donors are invited to include Samaritan in their estate planning, making use of a variety of tax saving and financially sound avenues for giving.
